# **Faithful Navigator's Report**



Worthy Sir Knights,

This fraternal year has started off with a number of opportunities for us, as Sir Knights, to show our patriotic support for our church and country. We participated in the Fairfax Independence Day Parade, served as Color Guard for the State Organizational Meeting, and provided liturgical Honor Guard for the parishes we support. I am proud that our Assembly has started strong in demonstrating the virtue of patriotism that is central to the 4th Degree. But, as we serve our mission in the 4th Degree, we should be mindful of the other virtues that make us Knights of Columbus.

Bradican, and Fr. Casey Assemblies. Coming up on August 13, we will be participating with Acts of Apostles Assembly in a memorial Mass for Fr. Nudd and wreath laying at the graves of Fr. Nudd and Fr. Malloy. The memorial Mass for Fr. Nudd will be at 12:30 PM at St. Timothy's (muster at Noon). The wreath laying will be at 2 PM at Fairfax Memorial Park. If you think of other opportunities to participate in events with other Assemblies, please let me know.

Fraternity should also be a virtue that we celebrate with other Knights of Columbus who are not yet 4th Degree members. Showing our brother Knights the importance of what we do in the 4th Degree and making them feel welcome and needed in our ranks is imperative if we are to grow the Assembly. As an example of extending fraternity to 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> Degree Knights, our September meeting will be an open meeting where non-Fourth Degree Knights can join us to learn more about what we offer in the 4<sup>th</sup> Degree and how they can get involved (including joining us for the November 11<sup>th</sup> Degree Exemplification).

Fraternity is a virtue that we must individually embrace but practice with each other. I look forward to working with each of you to help

our Assembly demonstrate the virtue of fraternity amongst the members of the Assembly, across other Assemblies, and to our brother Knights throughout the Order.

My Brother Sir Knights,

The Church proposes two devotions for August: the Blessed Sacrament and the Immaculate Heart of Mary. One might think that the Church just ran out of ideas for August because April is already dedicated to the Holy Eucharist and May, of course, is dedicated to Our Lady.

But this joint dedication for August is no accident. When we have right devotion to Mary it assures that we have right devotion to Jesus. In other words, everything we believe, honor, and celebrate in Mary has everything to do with Jesus. Mary doesn't make sense alone. We call her Mother of God because Jesus is God incarnate, and Mary gave birth to Jesus. We revere Mary as the Immaculate Conception because God preserved Mary from Original Sin so that He might have a fitting and worthy tabernacle for Jesus in the womb. In August, we recall that Mary was assumed body and soul into heaven because Jesus wanted His mother to share the fullness of Resurrected life where body and soul are united forever.

In his youth, St. Ignatius of Loyola desired a fight honorably for a noble lady. After his conversion, he recognized that every Catholic man should always uphold the great dignity of Our Lady. We do this because if we get devotion to her right, we stay close to her son.

# New Uniform for the 4<sup>th</sup> Degree

On Tuesday, August 1, the Supreme Master and Vice Supreme Masters of the Order debuted the new uniform of the 4<sup>th</sup> Degree during the Opening Mass at the 135<sup>th</sup> Supreme Convention in St. Louis, MO. During his address to the delegate later that day, Supreme Knight Carl Anderson stated:

"Throughout the history of the Fourth Degree, its official regalia has changed with the times. In 1940,



the white tie, tails, and top hat changed to the tuxedo, chapeau, and cape that we know so well. And in 1981, different colored capes and chapeaux were officially recognized. This fraternal year we make another historic change. The Board of Directors has decided that the time is right for a modernization of the Fourth Degree Uniform. This morning at the opening Mass of our Supreme Convention, our Vice Supreme Masters processed in wearing the new uniform of the Fourth Degree. Beginning today the uniform of the Fourth Degree is a blue blazer with Fourth Degree Emblem, dark-gray slacks, a blue Fourth Degree tie, white shirt, and a black beret with the Fourth Degree Emblem. On a limited basis, Assemblies may choose to continue using the traditional cape and chapeau for Color Corps at public events and Honor Guards in Liturgical Processions. However, the preferred dress for the Fourth



Degree, including Color Corps and Honor Guards, is the new uniform of the jacket and beret."

Three days later, Supreme Knight Anderson sent out a letter via email to all members of the Order with the following information:

"In light of this significant change, I thought it would be helpful to address some of the questions that have been asked about the new uniform.

- 1. The cape and chapeau, while popular among some Fourth Degree members, have become dated and are increasingly cited as a reason that eligible Catholic men, especially young men, do not join the Knights of Columbus.
- 2. Today there are nearly 2 million members of the Order, but only 358,000 of them are Fourth Degree Knights less than 20 percent. The old regalia was one reason often given by brother Knights for why they did not want to advance to the Fourth Degree.
- 3. We understand that some Fourth Degree members are fond of the old regalia. The cape and chapeau regalia will still be allowed, for a time, in those assemblies and districts that wish to use it, though the preference is for the new uniform.
- 4. Ceremonial swords will continue to be part of the Fourth Degree.
- 5. The new uniform is designed to be much more versatile than the older regalia and can be worn at a much wider range of functions.
- 6. Our choice of uniform, while important, has always been ancillary to the work we do carrying out the principles of charity, unity, fraternity, and patriotism, and this should always be the case.

We have been testing the new uniform over the past year with key groups of Knights, including those brother Knights who participate in our annual Warriors to Lourdes Pilgrimage. The feedback we received from these groups has been very positive."

At this time, we are awaiting directives from the Master of the Virginia District, SK Tom Trudeau, regarding implementation of the new uniform in Virginia. Until such time as we hear from Master Trudeau, we will continue to don the cape and chapeau as our Service Regalia. Once we receive the directives, we will advise the members of our Assembly.
